Kāinga Ora Contact: Brendon Liggett	79.140	2A.2.7	Oppose.	The provision does not align with the NPS-UD, wherein high-density development is encouraged around rapid transport routes. Kāinga Ora is opposed to provisions concerning reverse sensitivity, whether for infrastructure or otherwise. Effects should be managed 'at source' as far as practicable.	Waka Kotahi opposes the deletion of this policy on the basis that effects should be managed 'at source' as far as practicable. This suggests that the responsibility of managing noise is the sole responsibility of the transport network operator. There should be a shared responsibility for managing road traffic noise effects from the state highway because it is not practical nor reasonable for any one party to assume sole responsibility. Waka Kotahi, councils and landowners/developers all must assume responsibilities. The submission point also notes that this policy "does not align with the NPS-UD, wherein high-density development is encouraged around rapid transit routes". There are no existing or planned rapid transit stops within the Waipa District, therefore, Waka Kotahi does not understand how this part of the submission point is relevant to the policy.	Waka Kotahi seek the submission point be disallowed.

The submitter seeks that retirement villages are provided for as a permitted activity, with the construction of the retirement village being a restricted discretionary activity under a separate rule, recognising that retirement villages are residential activities that are appropriate in residential zones and provide substantial benefit in residential zones including enabling older people to remain in familiar community environments for longer (close to family and support networks), while also freeing up a number of dwellings for families to move into.</p>	<p>Waka Kotahi opposes retirement villages as a Permitted activity as they can have significant effect on the transport network, and therefore a full consideration of how such effects can be avoided, remedied, or mitigated is required. Waka Kotahi seeks that the activity status for a retirement village remains at minimum a Restricted Discretionary activity as per Rule 2.4.1.3.</p>	Waka Kotahi seeks that this submission point be disallowed.
